## Blog Guidelines

- 1. Write about 500—800 words.**
- 2. Use informal, simple language.**
  - Though we are tied to an academic institution, the blog format allows for more creativity and a relaxed voice. However, if you include substantiated claims, facts, or information from another source, please include hyperlinks to add credibility and a place for readers to go for more information.
- 3. Be provocative.**
  - We hope our readers will be encouraged to think in new ways, and if they disagree with a blog post, they'll have the opportunity to write one of their own expressing their perspective.
- 4. Include a catchy title.**
  - We can make one up for you, if necessary.
- 5. Provide photos.**
  - Please submit a related photo to be posted with your blog. This could include pictures of meetings, natural areas over which you are trying to collaborate, or anything else related to your work.
  - We must have permission to use the image. If the image is from the Internet, please secure permission to use it or find an image from a royalty free website. Include any copyright information and/or the photographer's name so we can properly attribute credit.
- 6. Include a bio and a headshot.**
  - Please submit a 2-3 sentence biography with links to your work and a headshot.
- 7. Email your blog to [angela.turnbow@law.utah.edu](mailto:angela.turnbow@law.utah.edu).**
- 8. Sign up for email notifications.**
  - Sign up for the blog [email list](#). This way, you'll know when your article has been published.
- 9. Share your work!**
  - Share your published blog with your contacts and cross post it to other relevant blogs, forums, and/or social media.
